District Measures - SBAC

At all schools and at each grade level, the percentage of grades 3-8 students reaching “*Standard Met*” or “*Standard Exceeded*” in both Math and English Language Arts will increase and District-wide scores will increase by 5% over 2014-2015 baseline results

Smarter Balanced (SBAC) results are scheduled for public release on August 15, 2016

District Measures - Writing

At least 80% of students in Grades 2, 4, and 8 will score an overall scaled score of “3” or “4” (out of 4) on the Opinion/Argumentative Writing Assessment

At least 80% of students in grades 3, 5, and 6 will score an overall scaled score of 3 (at standard) or higher (on a 4 point scale) on the full battery of MARS Assessments

District Measures - English Learner (CELDT)

75% of EL Students will show Adequate Yearly Progress (AYP) by increasing a minimum of one level on the CELDT annually.

70.4% showed Adequate Yearly Progress in 2015

District Measures - Additional English Learner Measures (Included in LCAP)

Percentage of reclassified students that maintain At or Above Standard on SBAC ELA and Math for two years (2018-19 Growth Target - >95%)

2014-15 Baseline = 83.5%

Percentage of EL's with 3 or more years in program that reach proficiency level on CELDT on summary level (Early Advanced or Advanced) or in each domain at Intermediate level (2018-19 Growth Target - 75%)

2014-15 Baseline = 61.4%

Percentage of EL's in Grades 4-8 proficient on CELDT and proficient on SBAC ELA (2018-19 Growth Target - 60%)

2014-15 Baseline = 47.9%
